**Re: CAS 2022/A/8803 24 Algurashi Local Football Association v. Sudan Football Association**

Dear Sirs,

I refer to the Reasoned Arbitral Award of 5 June 2023 rendered by the Court of Arbitration for Sport in the above-referenced matter.

Pursuant to Article R64.4 of the Code of Sports-related Arbitration (Code), the CAS Court Office shall determine the final amount of the costs of arbitration, which shall include the Court Office fee, the administrative costs of the CAS calculated in accordance with the CAS scale, the costs and fees of the arbitrators and a contribution towards the expenses of the CAS.
